*Data for non resident auto and air visitors is based on information provided by Marine Atlantic, CFIA, and boarding passenger statistics from the various airlines and data from the department's exit survey program.*

*Data for non-resident cruise visitors is based on trip itinerary and passenger data provided by the Cruise Newfoundland and Labrador. Estimates reflect activity during the full cruise season and represent a departmental estimate of non-resident individuals. This differs from overall passenger visits reported by Cruise Newfoundland and Labrador due to multiple port visits by some cruise ships.*

*Cruise Expenditures is based on survey data collected by the Economic Development and Tourism Department, City of St. John's. Expenditures reflect spending by passengers on shopping, restaurants, adockside tours and shore excursions.*

*The economic impact associated with cruise ship visits to the province is much larger and includes, for example, port fees and pilotage fees.*
