The Community Recreation Development Grants assist communities to: Provide accessible, inclusive recreation and active living and leisure programs while promoting the benefits of a healthy, active lifestyle; Develop the capacity of communities, groups and organizations to plan and deliver these programs and services and make them part of health promotion and disease prevention.

### **PROGRAM GOALS**

Better enable communities in the province with populations of 6,000 or less to be better served in physical activity, recreation and sport programs and activities; Increase opportunities and new initiatives for participation in structured and unstructured physical activity, recreation and sport; Increase use of community facilities; Promote inclusion of traditionally underrepresented populations especially women and girls, seniors, Aboriginal people, low income persons and those with disabilities; Increase the skills and knowledge of volunteers and community leaders in physical activity, recreation and sport.
